#### **Reports:**

#### **Grantville Volunteer Fire Company:**

Chief Saul Schmolitz stated GVFC had 15 calls in December (6-EHT; 6-WHT; 3 EHT Lebanon). Two Santa runs in the Township. Engine 39-1 had electrical issues and oil leak, which have been fixed. Now problem shifting and going into transmission shop tomorrow.

#### **Unfinished Business:**

Request to close Public Works Building NPDES permit and complete the As-Built Survey.

The Conservation District notified Township that the work at the Public Works Building is complete and acceptable. Proposal from K& W to complete "As-Built" survey and close out permit. Once the survey is complete, will be able to consider final payment to ECI Construction. Mr. Yingling made a motion to authorize K & W to complete the As-Built survey for \$8,335 from the Reserve Fund. Mr. Smith seconded. Motion carried 5-0.

#### Resolution for new Rental Rates

Mr. Yingling made a motion to accept the Resolution R-2020-08, the 2020 Fee Schedule for the Building and Pavilion. Mr. Smith seconded. Motion carried 5-0.

#### **Appointment of Supervisors to serve on Personnel Committee**

Board of Supervisors approved R-2019-17 to establish a Personnel Committee, two Township Supervisors need to serve. Mr. Smith made a motion to appoint Mike Yingling thru 12/20 and Chad Leese thru 12/21. Mr. Ciraula seconded. Motion carried 4-1. Mr. Leese voted No.

#### Talley Petroleum LDP-Authorization for Engineer Release of Financial Security

K & W Engineers have inspected and provided a report dated 12/27/19 recommending full release of the remaining financial security. Mr. Yingling made a motion for a full release of the financial security in the amount of \$19,687.40 for Talley Petroleum LDP. Mr. Smith seconded. Motion carried 5-0.

#### Consideration of appointment of Katrina Rish to fill vacant Elected Auditor Position

Mr. Yingling made a motion to appoint Katrina Rish to the vacant Elected Auditor Position. Mr. Smith seconded. Motion carried 4-0. Mr. Rish abstained.

#### Request to approve adjustment for Pesticide License spraying

Mr. Yingling made a motion to authorize an additional .50 per hour for Brandon Sell in the next pay cycle, for keeping and using the state license for weed control. Mr. Smith seconded. Motion carried 5-0.

#### **Business from the Public:**

Tina Hastie-Fox Run Road, looking to Township for better communications thru text blasting to keep residents informed on Township occurences.
