May 26, 2020

Members Present: Chad Leese, Chairman, Curt Cassel, Vice-Chairman, Kimberly Zimmerman, Steve Walters, and Greg Dovey.

Also Present: Jackie Wilbern, Assistant Township Manager, Aaron Moyer, P.E., HRG, and Andrew Bomberger, Dauphin County Planning Commission.

The meeting was advertised and held on the internet using a Zoom Application. Tina Hastie, a Township resident, also joined the meeting.

<u>CALL TO ORDER:</u> The meeting was called to order at 7:11 p.m., by Chairman Chad Leese.

<u>APPROVAL OF MINUTES:</u> Curt Cassel made a motion, seconded by Chad Leese to approve the minutes of the April 29, 2020, regular meeting minutes as presented. The motion carried with a 4-0 vote.

## PLANS TO BE DISCUSSED:

- Mountain Trail Realty, LLC Subdivision Acceptance of the Plan for Review (due date July 28, 2020.) Jim Hillard, Plan Engineer, presented the plan. DCPC Representative, Andrew Bomberger noted there would need to be a waiver for the 80-foot right-of-way requirement for the state road, under Section 602.3.1.1. Mr. Hillard was advised to reach out to PennDOT for their written support of the waiver request. Township Engineer Aaron Moyer explained there would be no reason why the Township Planning Commission can't recommend to grant that waiver, especially since it would be just in front of that one parcel where it would be the 80-foot right-of-way.
- Preliminary/Final Land Development Plan for North Faith Road Property for Indiju Hospitality 2, LLC - Due date August 1, 2020 – Tabled, no discussion.

Subdivision and Land Development Ordinance (SALDO) rewrite.
