CALL TO ORDER: The Meeting was called to order at 7 pm by Ken Wolensky.

- B. Vice Chairman-Steve Walters made a motion to reappoint Curt Cassel as Vice-Chairman of the East Hanover Township Planning Commission. The motion carried with 4-0 vote.

<u>APPROVAL OF THE MINUTES, NOVEMBER 23, 2021</u>: Steve Walters made a motion, seconded by Curt Cassel to approve the minutes of the November 23, regular meeting as present. The motion carried with a vote of 4-0.

PLANS TO BE DISCUSSED:

- Grantville Commons LDP (Due date February 20, 2022) Bill Anderson, Atwell Engineering and Joel Brown, Owner were present. Looking for formal action on 7 waivers.
 - SALDO Section 602.13- Cul-de-Sac Streets-Chief Schmolitz was asked for his opinion regarding an emergency access gravel driveway proposed by the developer. The driveway needs to withstand the weight of a ladder truck (72,000 lbs.). Bill Anderson (Atwell Group, Bryan Clement (H.F. Lentz Co.) both stated the access drives have strengthened and there is a turnaround area (15ft wide pull off) with gates indicated on these driveways. Steve Walters made a motion to recommend approval of the waiver for SALDO 602.13 Culde-Sac, seconded by Curt Cassel. Motion carried 4-0.
 - SALDO Section 605.3.7 Radii at Intersection-Curt Cassel made a motion to recommend approval of the waiver for SALDO 605.3.7 Radii at Intersection, seconded by Doug Huyck. Motion carried 4-0.
 - o SALDO Section 625- Lighting-Bill Anderson stated lighting plan has been revised to add double the lighting. Discussed different lighting options.

- Grantville Commons Land Development Plan. Steve Walters made a motion to recommend approval of the LDP conditioned upon all technical comments in HRG letters dated 1/10/22 & 1/25/22 are met, seconded by Curt Cassel. Motion carried 4-0. Steve Walters made a motion to accept the 90-day time extension from 2/20/22 to the Township by the developer, seconded by Doug Huyck. Motion carried 4-0.
- P/F LDP for North Faith Road Property for Indiju Hospitality 2, LLC (Due date April 22, 2022). Ron Secary of Snyder Secary & Associates presented that Spring Hill Suites is down to a single issue. The one outstanding waiver for SALDO Section 501.A.6. Wanted to move waiver request & plan approval forward even though plan tabled.
