JOB DESCRIPTION: The East Hanover Township's Summer Recreation Camp runs for 7 weeks, from June 17th to August 2nd, 2024. We accept children entering 1st grade through 8th grade in the 2024-2025 school year. The children attend Mondays-Fridays from 9am-12noon (Counselors work daily 8:30 am-12:30 pm with a few exceptions). The camp starts June 17th (Monday), and the last day is August 2nd. This program is designed to provide supervised outdoor recreational opportunities for children including arts and crafts, special events, organized games, creative play opportunities, and theme-based activities. Staff shirts and CPR/AED/First Aid training are provided for hired staff.

- Must be 15 years of age or older with a minimum of 1-year experience working/volunteering with children OR a willingness to learn.
- Must be CPR/AED and First-Aid Certified by the first day of camp (in-house/online training is available for hired staff).
- Expected to be active, mature, responsible, enthusiastic, engaging, hands-on, committed to being a good role model, invested in working efficiently as a leader and team member with staff, and proficient at facilitating daily activities.
- Expected to come to work on time and with a positive attitude.
- Expected to communicate professionally with parents, co-workers, and children.
- Must receive Child Abuse, Criminal History, and FBI background checks, paid for by EHT.
- Must commit to working at least 6 out of the 7 weeks of the program. Requests for time off MAY be approved if coverage permits.
- Those hired who are under the age of 18 are required to provide a copy of their work permit from the school.
- May be offered voluntary additional work opportunities beyond Summer Rec Program through the end of the calendar year to assist the EHT Parks & Recreation Director with Department special events.
- Must follow and enforce all safety protocols from the time you arrive at the park until the time you leave.

INTERVIEW PROCESS: Applicants are expected to schedule an interview with the Camp Director and Parks & Recreation Director no later than April 8th to 717-469-0833 x202.

• We encourage you to bring an idea to the interview for a game, STEM activity, or craft that kids (between the ages of 6-13) could enjoy.
