**A RESOLUTION BY THE BOARD OF SUPERVISORS OF EAST HANOVER
TOWNSHIP, DAUPHIN COUNTY, PENNSYLVANIA, SETTING THE
TOWNSHIP FEES FOR 2017**

The Supervisors of East Hanover Township, Dauphin County, Pennsylvania, resolve as follows:

Subdivision plans and residential land development plans:

\$100.00 base fee, plus \$ 50.00 per lot or unit

*In addition to the Township fee, an application fee will be charged by the Dauphin County Planning Commission – per fee schedule

*All Township Engineer review and inspection fees will be paid for by the Applicant

Land development plans:

\$200.00 for the first acre or fraction, plus;

\$100.00 for each additional acre or fraction

*In addition to the Township fee, an application fee will be charged by the Dauphin County Planning Commission – per fee schedule

*All Township Engineer review and inspection fees will be paid for by the Applicant

Stormwater Management Permit Fees – Major Land Disturbance \$500.00
Minor Land Disturbance \$100.00

Recreation fee-in-lieu of land for new dwelling units and/or lots to be used for residential purposes: \$1,040.00 per new unit or lot.

Reviewing engineer fees: as per Resolution 2016-19

Sewage enforcement officer fees: as per Resolution 2016-19

Annual Mobile Home Park permits: \$25.00 park registration fee; plus \$2.00 per unit.

Annual Septic Hauler/Pumper license fee: \$20.00

Annual junk yard permits: \$100.00

Residential driveway permits: \$25.00

*Driveway permits along State roads, refer to PennDOT fee schedule

Oversized vehicle permits: \$25.00

Special Exception \$450.00 Fee

Conditional Use \$450.00 Fee

Variance & Appeals	\$450.00 Fee

Curative Amendment	\$2,500.00 Fee, Plus all advertising & court reporter fees paid by applicant.
Text Amendment	\$250.00 Fee Plus all advertising & court reporter fees paid by applicant.


